However, make no mistake, abortion is alive and well in the Buckeye State. All the abortion mills in Ohio are still performing chemical/medical abortions until they can discern a heartbeat via ultrasound."

Several of the state's abortion facilities are referring their surgical appointments to out of state facilities. For example, Dayton's Womens Med Ctr operated by Martin Haskell, is sending patients to his Indianapolis office. We advise our sidewalk counselors and prayer warriors however, to stay vigilant and present.
